It also provides services and referrals to relatives raising children as well as services to the elderly and disabled. In addition, Family and Children Services provide daycare programs and Head Start in metro Denver through several child care centers including the Margery Reed Mayo Center.

4b (Code:) (Expenses \$ 7,799,209. including grants of \$ 2,041,720.) (Revenue \$ 1,005,858.)
The Shelter and Community Outreach Services division provides temporary shelter and meals as well as case management for homeless persons at Samaritan House, Marisol Home, and St. Joseph's Home for Veterans in the metro Denver area. It also provides employment referrals and assistance, transitional housing services to individuals and families, and immigration assistance. In addition, emergency assistance is provided to individuals and families in need of basic necessities in metro Denver.

The Weld County division provides temporary shelter and meals as well as case management for homeless persons at the Guadalupe Shelter in Greeley. In addition, it also provides services to low-income seniors, and emergency assistance to individuals and families in need of basic necessities in Weld County and the surrounding area.
