In addition, Family and Children Services provide daycare programs and Head Start in metro Denver through several child care centers including the Margery Reed Mayo Center.

4b (Code: ) (Expenses \$ 17,222,182 including grants of \$ 2,682,608 ) (Revenue \$ 851,843 ) The Shelter and Community Outreach Services division provides temporary shelter and meals as well as case management for individuals experiencing homelessness at Samaritan House, Marisol Home in the metro Denver area. It also provides employment referrals and assistance, transitional housing services to individuals and families, and immigration assistance. In addition, emergency assistance is provided to individuals and families in need of basic necessities in metro Denver.
